CEO Michael GoepfARTH to remain on the Advisory Board; Interim Leadership by Clemens Lay and Antonio Cavotta

Clemens Lay, who joined SCIO in January 2025 as Chief Financial Officer, brings extensive experience from previous CFO and CEO positions and plays a key role in advancing the Group’s financial integration and strategic scaling. Antonio Cavotta, who joined SCIO in 2021 as Head of Sales and Managing Director of SCIO Automation Munich, later advanced to Executive Vice President of the Production Solutions business segment. In this role, he has been instrumental in shaping and expanding the segment – one of SCIO’s core competence areas in Europe and North America.
